

Generative AI is an emerging technology that produces highquality text, images, voice recordings, and videos derived from data. By utilizing deep-learning models, generative AI makes content that appears as if a human made it.

Scammers use generative AI maliciously. They use it to mimic friends, family, coworkers, and celebrities. This technology can trick others into revealing sensitive information, thereby setting victims up for fraud and theft.

Don't let scammers use Al against you. When using social media or checking messages:

- Verify senders who are contacting you.
- Avoid the impulse to engage with posts or requests immediately.
- Be skeptical of messages that feel out of the ordinary.
- Limit what you share on social media.

Making Sense of Medicare Parts A, B, C, and D

Medicare is available to most U.S. citizens and legal residents 65 years of age and over who have previously worked and paid U.S. taxes or who are/were married to someone who did. Medicare has four parts.

Medicare Part A: Hospital Insurance

Part A covers hospital stays, skilled nursing facility care, nursing home care, hospice care, and home health care. You won't pay a premium for Part A as long as you or your spouse has made contributions to Social Security for at least 10 years.

Medicare Part B: Medical Insurance

Part B covers doctor visits and other medical services, such as outpatient care at hospitals, durable medical equipment, laboratory tests, and some nursing care.

Medicare Part C: Medicare Advantage

Private insurance companies offer Part C plans that cover certain hospital costs, doctor visits, and other services. Part D coverage may also be included in these plans.

Medicare Part D: Prescription Drugs

Plan D applies to prescription drug coverage offered by private insurance companies. Coverage and pricing vary according to plan.

Nomination for Vacancies on the **Board of Directors by Petition**

Nomination for vacancies on the Board of Directors may be made by petition, signed by at least 1% of the members. Nomination by petition must be filed with the secretary of the credit union by mail (First Florida Credit Union, Secretary, P.O. Box 43310, Jacksonville, Florida 32203-3310). Nominations must be received no later than Tuesday, December 30, 2025. Emails or faxes will not be accepted. To be effective, nomination by petition must be accompanied by a signed certificate from the nominee stating that they are agreeable to nomination and will serve if elected. A statement of qualification and biographical data must be submitted with the petition.
